TERMS AND CONDITIONS

To make your time with BULLDOG SHUTTLE AND CAB, LLC (BSC) an enjoyable one, we ask for your cooperation with the following:

BSC will strictly enforce State and Federal Laws and will maintain a zero tolerance compliance policy that no alcoholic beverages can be consumed or used by any person not of legal drinking age. All U.S. law enforcement agencies have absolute power to stop any motor vehicle for administrative searches. If contraband is aboard, even in negligible quantities without the chauffeurs' knowledge, they can seize and forfeit this vehicle to a local government agency. All law enforcement agencies are expressly enforcing this policy; therefore, no person will bring contraband aboard vehicles that are owned and/or operated by BULLDOG SHUTTLE AND CAB. BSC will not be held responsible for injuries that may occur due to horse playing while the vehicle is in motion, at a standstill or entering and exiting vehicle. The purchaser listed on this contract is responsible for his or her guests.

BSC recommends that any and all personal valuables be removed from the vehicle when unattended. We will not be held responsible for any lost, stolen or damaged articles. BSC reserves the right to terminate this or any other contract for noncompliance of the above request, especially if renters do not follow chauffeurs' requests in order to obey the rules in this contract. No smoking is allowed in our vehicles.

If the contract is cancelled prior to 72 hrs of contracted service date, all deposits (cash or credit card authorizations) are refundable. If cancellation occurs less than 72 hrs of contracted service date; BSC is still authorized to collect the remaining balance in full, if the vehicle is not re-rented again on the contracted service date for the same or higher amount. If cancellation occurs less than 72 hrs of requested service, all deposits are forfeited. The renter authorizes an immediate 50% deposit & the remaining balance is due immediately upon pickup. The authorized cardholder for the given credit card is responsible for the payment of the total amount, per cash, credit card or money order. As with all contracts, all of the given information from the renter is binding and cannot be changed without BULLDOG SHUTTLE AND CAB'S acceptance. _____ **Initial**

We will reserve the said date upon the approval of the purchaser's credit card as per telephone conversation. The credit card holder gives authorization to use the credit card information over the phone / fax / internet in combination with signed contact.

At time of the pick up we need the credit card, state identification of the purchaser that authorizes the transaction of the signed contract. If the purchaser cannot provide all of the above items at the time of the pickup, BSC will not start the job, as we have no proof of the legal possession of the credit card. Therefore, the risk of not getting paid will give us the right to cancel. The purchaser is still fully responsible to pay the total amount as he/she failed to provide the above requirements. BSC cannot guarantee the availability of overtime.

The number of guaranteed hours is not used to calculate total payment due. Travel time is travel from office to pickup location and from drop off location to home office. Total hours will include any and all travel time. Travel time from home office and back to home office will need to be taken into account when guaranteeing hours.

Transfer jobs are priced for immediate pickup/drop-off, no wait time is included, no usage of bar or drinks/food etc. Base price is simple transportation. The overtime for transfers will be billed by ¼ of hourly rate or ¼ of transfer charge. If customer fails to show at designated pick up location and does not inform office and/or chauffeur, the full amount of the contracted time will be charged.

TERMS AND CONDITIONS CONTINUED

The purchaser authorizes BSC to charge any additional charges after they rendered services to the purchasers' credit card.

A 20% gratuity will be added to your total hourly charge. If cash payment is selected, the payment is due at the time of the beginning of the rental time. Customer agrees to have BSC get the authorization for the above credit card and the amount, for the event stated above. BSC shall not be held responsible for late arrival caused by (but not limited to) act of nature, traffic delays, breakdown, incorrect pickup and drop-off information, and any situation beyond our control. If the vehicle rental is to be for a minor under the age of (18) eighteen, this agreement must be signed by either a parent or legal guardian over the age of (18) eighteen.

I, the credit card holder / purchaser, agree to pay BULLDOG SHUTTLE AND CAB upon signing this contract.

I am satisfied with the terms and conditions above and fully understand and agree. Since BSC offers high-tech-equipped vehicles sometime heat and excessive use of all power-operated equipment might be subject to temporary failure. This will of course not interfere with the safety of the vehicles itself and therefore will have no effect on continuing or paying of the contracted trip. BSC guarantees, that all our vehicles are constantly checked to keep the highest possible standards and eliminate such failures as much as possible. BSC agrees to send the requested vehicles as offered in the contract. We have the right to upgrade the vehicles or switch the vehicles in case of emergency breakdown or if the vehicles were in accidents. As stated, this will only happened in emergencies, and to upgrade, never downgrade. If no upgrade is available, BSC gives the customer the right to downsize the vehicle and receive additional discounts if wanted. No additional charges will occur if upgrade is made without customer request. If switching occurs in the same category, or upgrades are made, it will not affect the contract and / or payment of contract. Customers therefore accept that replacement vehicle may be substituted if contracted becomes unavailable for any reason.

I understand that I must be at least 21 years of age at the time this contact is submitted to BSC; a photo ID will need to be provided to verify age. I understand that I am responsible for all passengers' actions, vehicle damages, and payments.
